3. Premises and facilities

3.1 The academy will make the main hall, sports hall, classrooms or private meeting rooms available for interactions between the provider and students, as appropriate to the activity. The academy will also make available all reasonable requests for specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the careers leader or a member of their team.
