|            | Most governors in attendance confirmed that they had viewed the training and found it interesting, the remaining governors will watch the training following the meeting when access and technical issues have been resolved. Mr Knight addressed the committee and asked if governors prefer to receive the training to view in their own time and governors agreed that it was a better use of time to view training prior to the meeting.   |                           |
|            | <u>The governors asked</u> about the building blocks covered by the training <u>and questioned</u> how strong the links are with the KeyStage2 feeder schools. Mr Dickinson explained that Retford Oaks students come from around 40 different primary schools, the academy has good relationships with the core local group of schools, two of which are part of Diverse Academies Trust but went on to describe the work that goes on with the year 7 students to understand the level that students are at when they arrive at the academy. |                           |
|            | The governors requested further clarity around the Ofsted Deep Dives that are done and asked how may subjects Ofsted will perform deep dives in. Mrs Widdup said that it will depend upon the nature of the visit but usually they will focus on 4 or 5 subjects. She added that the academies do their own deep dives regularly using the Ofsted format. The governors asked if the academy is able to influence the subjects that Ofsted will focus on and Mrs Widdup explained that they cannot.  |                           |
|            | <u>Governors wondered</u> if there had been any further community engagement recently at the academy and Mr Dickinson explained that a significant sum, around £1200, had been raised as part of fundraising activities last week in support of Comic Relief and <u>Young Lives vs Cancer</u> and added that students had conducted themselves excellently.  |                           |

Mr Dickinson agreed that students need to be responsible for their own litter and added that there are also external factors which contribute to the state of the site because it is a PFI and therefore local clubs using the facilities often leave rubbish behind. <u>Mr Knight went on to ask</u> if the leaking roof along the corridor had been repaired yet and Mr Dickinson confirmed that the issue is ongoing. |   |
|            | <u>The governors asked</u> if there is an update in terms of the planned dining hall extension. Mr Dickinson explained that the proposal is currently with the trust who are speaking to the county council. <u>Governors noted</u> that they had not heard as many grumbles recently about the dining space <u>and asked</u> if things had settled somewhat. Mr Dickinson explained that issues are often more challenging in the Autumn term when new year 7 students are learning the system but once they are more settled, issues generally reduce.  |   |

|            | The governors asked Mr Dickinson and Mrs Widdup if there are any specific areas that might benefit from some support from governors. Discussion followed and it was agreed that Mr Morgan would look at Pupil Premium (PP), Miss Luke would look at Transition and Equality, Diversity and Inclusion (EDI) and that Miss Bridgeman would work with Post 16.  |                           |

| AC/48/2324 | Principal's report  Mrs Widdup referred to the Educational Review Meeting (ERM) report which was circulated prior to the meeting and explained that the focus of this report is around attendance and year 11 outcomes.  |                           |
|            | Attendance is starting to show improvement which is very positive particularly in year 11 which is up 7% on last year. Persistent Absence (PA) has also seen significant improvement reporting at 22% lower than last year.  |                           |
|            | Mrs Widdup went on to discuss year 11 outcomes, explaining that she meets regularly with Mr Olley and Mr Spooner to look at where students are in terms of their progress and how they can be helped to be moved forward. There is a document for each individual student which is extremely focussed, they are then filtered into colour coded cohorts based on their progress 8 (P8) scores. This enables planning to better support the students' needs, for example the red cohort have P8 scores that are the furthest from their targets and are the current focus for additional TA and mentoring support. Mrs Widdup added that she has met with the SENCO to ensure that all the relevant support is in place for the year 11 students.             |                           |
|            | Mrs Widdup went on to state that Retford Oaks is not unique in that many students do not take their revision work home. This is something that has been identified across the trust and beyond. It is therefore important to ensure that valuable work is done in the classroom. Wherever possible specialist teachers are available to support students with revision work. Consideration is also being given to the start times for morning exams to take account of the issues with the local road network to reduce stress on students, allowing them time to settle before the exam begins. Staff are focused on looking at current abilities rather than targets to ensure students are working at the right levels and maximising their capabilities. |                           |
|            | Mrs Widdup explained that the number of subjects being studied by students (the current year 9 cohort) when they come to choose their options will be reduced and explained that rather than selecting 4 options which are studied during 3 lessons each week for each subject. They will select 3 options to be studied in 4 lessons per week, it is expected that this will achieve greater results. Mrs Widdup added that the head of year 11, Mr Olley and Mr Spooner know the students extremely well and are supporting  |                           |

|         | The recent staff training day on 19th February was focussed around how to            |             |

|         | an additional lesson per subject each week. <u>Governors asked</u> how the           |             |

|         | that booster sessions are timetabled around the exams and that as exams              |             |
|         | are completed the timetable gradually reduces. Support will remain in place          |             |

|         | external safeguarding review was completed in January and no issues were identified. |             |
|         | Behaviours – there have been no further Permanent exclusions following               |             |

|         | Suspensions – the number of suspensions has dramatically reduced this year           |             |
|         | and are currently at 2.8% as opposed to just below 10% last year. Some of            |             |
|         | this is because of the ability to utilise the 'in house' alternative provision at    |             |
|         | the Retford Education Centre rather than suspension. There was a                     |             |
|         | significant change in attitudes following the lockdowns and a reset was              |             |
|         | required, which has taken some time to settle down but appears to be                 |             |
|         | turning the corner now. Mr Dickinson added that of significant note is the           |             |
|         | shift in the number of SEND students being suspended. Last half term fewer           |             |
|         | SEND students were suspended than non-SEND. <i>The governors asked</i> if Mr         |             |
|         | Dickinson could put that down to activities and changes in provisions that           |             |
|         | have been made rather than it being coincidental. Mr Dickinson explained             |             |
|         | that the capacity to "manage" behaviours rather than opt for suspension              |             |
|         | has had a significant impact. Students can work at the alternative provision         |             |
|         | for a short time. Other changes, such as repositioning of the HUB and access         |             |
|         | to support for students with SEND have also seen results. <i>The governors</i>       |             |
|         | <u>asked</u> if there are lessons learned or good practice that can be shared from   |             |
|         | the change to suspensions for SEND students that might help tackle                   |             |
|         | suspensions amongst the PP cohort. Mr Dickinson explained that much of               |             |
|         | this is to do with knowing the individuals and their circumstances and added         |             |

|         | The Fire safety report has identified some white goods/machinery in an area that needs to be rectified. <i>The governors asked</i> if there are any students with Personal Evacuation Plans. Mrs Widdup explained that all students in need of assistance have individual risk assessments. Mr Dickinson went on to inform governors that compliance training is up to date and a fire evacuation is planned before Easter.  |                           |
|         | Complaints – The 1 complaint reported on within the principals report was rectified in a meeting with the parent last Friday. There is a backlog of GDA paperwork that needs to be completed and this has had an impact on recent issues and early-stage complaints received.  |                           |
|         | Curriculum – Mr Dickinson expanded on the earlier discussion around the change planned to the curriculum in terms of option choices from September 24 and added that compulsory GCSE RE will be removed from the curriculum, the statutory elements to be delivered during PSHE. The time created in timetables from removing RE will enable all students to study individual sciences rather than the combined award. <i>The governors questioned</i> the move from combined to triple sciences and shared concerns that individual sciences were considered more difficult. Mr Dickinson explained that the progress scores seen at Retford Oaks indicate that students perform better in individual sciences but reassured governors that there is flexibility within the timetable to bring students back to the combined science if they are struggling. Mr Dickinson explained that the curriculum changes have been communicated with parents and will be reiterated at the upcoming options evening. <i>Governors wanted to know</i> if parents had been receptive to the changes and Mr Dickinson confirmed that he had received no backlash from parents, Options Evening is next week and this will be an opportunity to address any concerns directly. Further discussion followed around the sciences and clarity was given around the grading of combined science compared with individual sciences. The 3 individual sciences are graded separately, whereas the combined science takes an average grade from all 3 sciences so a poor performance in one of the sciences will bring the entire grade down for the combined GCSE. |                           |
|         | Mr Dickinson referred to the details shared prior to the meeting in relation to the trips being offered and governors were happy to see students being rewarded for good work, learning being enriched and that trips have been successful. Mr Dickinson added that a trip to Wembley to watch the women's football was arranged after the trips calendar had been shared.   |                           |
|         | Governors referred back to the discussion around the curriculum and asked if it was cost effective for the academy to offer 3 modern languages at GCSE when the uptake is very low. Mrs Widdup explained that this was a legacy from primary schools where children had been learning different languages at different schools but confirmed that German has now stopped with French and Spanish still being taught. Mr Dickinson added that everything is   |                           |

|            | currently 63 students in year 12 now and the attendance for year 12 is now                          |             |
|            | at 95.2% which is very positive. Mr Knight acknowledged that he felt sixth                          |             |
|            | form to be a positive environment from his recent visits. <i>The governors then</i>                 |             |
|            | <u>questioned</u> if there were any early indications as to what GCSE results will                  |             |
